Steve will contact the Highway Department for a bid to add 6" of gravel to the north section, and 3" to remainder of the ground section. Depending on the availability of the Highway Department, a special meeting may have to be scheduled. The private party on Klarquist that requested a culvert, still has not installed it. Cory will re-pipe the bathroom for proper drainage within a couple of weeks.
