The regular monthly meeting was held on Wednesday, June 19, 2019 at 7:00 pm, at the Lincoln Town Hall.

The meeting was called to order by Chairman, Steve Washkuhn at 7:00 pm.

Motion to approve the agenda order was made by Cory Jackson, seconded by Joe Peterson. 3-0 motion carried.

Motion to approve the minutes of the May 8, 2019 regular meeting was made by Joe Peterson, seconded by Cory Jackson. 3-0 motion carried.

Motion to approve the minutes of the May 22, 2019 Board of Review minutes was made by Steve Washkuhn, seconded by Cory Jackson. 3-0 motion carried.

PUBLIC COMMENTS: Mike Verdon, resident of Lincoln Township was present to express his concerns regarding water/culvert issues on Helsene Road. Steve will have the Highway Department look at drainage possibilities when the grinding/resurfacing is done.

The mower is presently being serviced at the Highway Department. Steve will let Jim know when it is ready to pick up.

Jim has been doing patching. He filled the hole in Moline Road. Jim will keep an eye on it as it is a very large sinking hole.

The Highway Department has completed the gravel project on Nelson Road. Due to unavailability, the Town of Lincoln hired the maintenance worker/grader from the Town of West Marshland. The Highway Department is scheduling the gravel project for Beal Road in the near future. The estimated cost for Beal Road is \$52,647.00. The Forestry grant will pay \$11,000.00 on this project, for a balance of approximately \$41, 647.00.

The Highway Department will also take care of the culvert situation on Klarquist Road and Corcoran Road.

Steve provided a spreadsheet of the recent road tour. Board discussed projects to complete this year. Motion was made by Joe Peterson, seconded by Cory Jackson to complete the following projects:

1. Gravel and grind Lee Road
2. Gravel and grind N/S Helsene Road
3. Gravel and grind E/W Olsen Road
4. Grind Bjorklund Road
5. Polyseal Ice House Bridge Road north of bridge and South River Road to Town line

Motion to approve Liquor License for Sweeny's Bar for the period of July 1, 2019 – June 30, 2020 was made by Joe Peterson, seconded by Cory Jackson. 3-0 motion carried.

Joe Peterson explained a change made on the Perida cemetery map.

Correspondence was looked over.

Motion to pay monthly bills as presented was made by Joe Peterson, seconded by Cory Jackson. 3-0 motion carried.

Motion to adjourn was made by Cory Jackson, seconded by Joe Peterson.
