ROAD MAINTENANCE: Jim will be patching tomorrow with the assistance from the Highway Department. The Highway Department will provide one man, truck and trailer. Jim stated the beaver problem appears to be better.

Steve checked with Lee's Sport & Saw to replace the chainsaw that was stolen from the town garage. The amount is \$550.00. Wanda is working with Rural Insurance on the claim for this. Motion to purchase chainsaw was made by Cory Jackson, seconded by Joe Peterson. 3-0 motion carried.
