The regular monthly meeting was held on Wednesday, July 14, 2021 at the Lincoln Town Hall, located at 9110 Perida Road Webster, WI at 7:00 pm.

The meeting was called to order by Chairman Steve Washkuhn at 7:00 pm.

Motion to approve the agenda order was made by Joe Peterson, seconded by Steve Washkuhn. 2-0 motion carried.

Motion to approve the minutes of the June 9, 2021 Regular Meeting was made by Joe Peterson, seconded by Steve Washkuhn. 2-0 motion carried.

Motion to approve the June 2021 Treasurer's report was made by Joe Peterson, seconded by Steve Washkuhn. 2-0 motion carried.

Bob Pardun, current Assessor for the Town of Lincoln, presented and proposed an agreement for his services effective January 1, 2022 through December 31, 2023, in the amount of \$6,500.00. Motion to accept the agreement was made by Joe Peterson, seconded by Steve Washkuhn. 2-0 motion carried. Official Oath was acknowledged and signed by Bob Pardun.

The first half of the American Rescue Plan Act (ARPA) funds have been deposited in the Town of Lincoln's account. The U.S. Treasury Department is still finalizing

guidance on the use of these funds. We will consult with our local community and its leaders on how to effectively and strategically use the funds.

Discussion on the fall pre-buy program through Northwoods propane. Motion by Joe Peterson, seconded by Steve Washkuhn, to pre-buy 1,000 gallons of propane at \$1.459 per gallon. 2-0 motion carried.

ROAD MAINTENANCE: Jim reported that all roadside mowing has been completed and that he has been doing some patch work. Discussion on sink holes that are developing on the new part of Klarquist road. More gravel has been hauled to Lincoln road and the project is halfway complete.

OLD BUSINESS: Joe reported that a new door for the town shop has been ordered by Dale Larson. Discussion on potential modifications to the Comprehensive Plan due to the townships changing needs and desires.

Correspondence was looked over.

Motion to approve monthly bills as presented was made by Joe Peterson, seconded by Cory Jackson. 3-0 motion carried.

FUTURE AGENDA ITEMS: With no further business to come before the Board, a motion to adjourn was made by Steve Washkuhn, seconded by Joe Peterson. 2-0 motion carried.
