The Annual Town Meeting was held on Tuesday, April 19, 2022 at 6:00 pm, at the Lincoln Town Hall located at 9110 Perida Road, Webster, Wisconsin.

Meeting was called to order at 6:00 pm by Chairman, Steve Washkuhn.

Motion to approve the agenda order was made by Cory Jackson, seconded by Joe Peterson. 9-0 motion carried.

Chairman, Steve Washkuhn asked for preference on voting procedure of either show of right hand or ballot. Motion for show of right hand was made by Claudia Kurschner, seconded by Nancy McDevitt. 9-0 motion carried.

Newspaper advertising: The Township posts notices in the Indianhead Advertiser for only required meetings by State Statute. All other notices are posted at the cemeteries, the town hall, and our website. Motion to continue this practice was made by Stacy Gaffney, seconded by Cory Jackson. 9-0 motion carried.

Sale of misc items: The Town of Lincoln currently has authority to sell non-motorized items under \$500.00. Motion to continue this practice was made by Joe Peterson, seconded by Cory Jackson. 9-0 motion carried.

Bounties: Motion was made by Cory Jackson, seconded by Joe Peterson, to leave the gopher bounty at \$2.00, and beaver at \$20.00. 9-0 motion carried.

Cemeteries: Claudia Kurschner and Nancy McDevitt have volunteered to be part of a cemetery committee. Gary Erickson has also volunteered to be part of the committee as well. May 5th will be clean up at Perida cemetery and clean up at Karlsborg cemetery will be scheduled at later date. Steve Washkuhn will again mow the cemeteries.

Salaries: Chairman's salary is \$4750.00 per year. Motion to remain at \$4750.00 was made by Joe Peterson, seconded by Cory Jackson. 9-0 motion carried.

Supervisor salary is \$3750.00 per year. Motion to remain at \$3750.00 was made by Stacy Gaffney, seconded by Wanda Washkuhn. 9-0 motion carried.

Clerk's salary is \$14,000.00 per year. Motion to remain at \$14,000.00 was made by Joe Peterson, seconded by Cory Jackson. 9-0 motion carried.

Treasurer's salary is \$7500.00 per year. Motion to remain at \$7500.00 was made by Wanda Washkuhn, seconded by Cory Jackson. 9-0 motion carried.

Election workers receive \$13.00 per hour. Motion to remain at \$13.00 per hour was made by Wanda Washkuhn, seconded by Joe Peterson. 9-0 motion carried.

Chief Election Inspectors receive \$15.00 per hour. Motion to remain at \$15.00 per hour was made by Wanda Washkuhn, seconded by Stacy Gaffney. 9-0 motion carried.

The standard labor rate is \$17.00 per hour. Motion to remain at \$17.00 per hour was made by Joe Peterson, seconded by Cory Jackson. 9-0 motion carried.

Mileage: Motion to follow State rate was made by Steve Washkuhn, seconded by Joe Peterson. 9-0 motion carried.
