The meeting was called to order at 7:00 pm by Chairman, Steve Washkuhn.

Motion to approve the agenda order with the addition of Gravel Quotes under road maintenance was made by Joe Peterson, seconded by Steve Washkuhn. 2-0 motion carried.

Motion to approve the minutes of the May 11, 2022 meeting was made by Joe Peterson, seconded by Steve Washkuhn. 2-0 motion carried.

Motion to approve the minutes of the May 11, 2022 Board of Review was made by Steve Washkuhn, seconded by Joe Peterson. 2-0 motion carried.

Motion to approve the May Treasurer's report was made by Joe Peterson, seconded by Steve Washkuhn. 2-0 motion carried.

ROAD MAINTENANCE: Jim has picked up the mower from the Highway Shop. Lincoln will be first for the rotation this year. Jim has done patching. Steve received the following estimates from the Burnett County Highway Dept.

1. Graveling 1.2 miles of Helsene Road
4 inches =\$20,451 6 inches = \$32,657

2. Graveling .46 miles of Welch Road
4 inches = \$10,796 6 inches = \$14,117
3. Graveling .43 miles of N. Fork Dike Road
4 inches = \$10,455 6 inches = \$13,150

Motion was made by Joe Peterson, seconded by Steve Washkuhn to apply 6 inches to all three roads in the amount of \$ 59,924.

Steve will contact Jeremy Burton at the Highway Dept to set up grinding for Helsene Road and will let Ike know when it is scheduled so he will be available with the grader.

Steve talked to Mathy regarding Lhotka Road. Steve suggested a possible blade patch on the low spot. Discussion on East Black Brook Road for 2023.

Liquor license application from Matt Swenson/Sweeny's Bar was reviewed and a motion to approve licensing as presented was made by Joe Peterson, seconded by Steve Washkuhn. 2-0 motion carried.

Comprehensive Plan: Cory received a cost proposal from NWRPC in the amount of \$5550.00 . The cost does not include staff travel time or meeting attendance. This be further discussed at next month's meeting.

OLD BUSINESS: Wanda received a complaint call on a residence on Black Brook Road. Steve will talk with Jason Towne.

A motion was made by Steve Washkuhn seconded by Joe Peterson to Gift Jim Petersen and Family in the amount of \$500.00 for the unexpected loss of their son. 2-0 motion carried.
