

PUBLIC ACCESS DIRECTIONS

1. www.burnettcounty.com
2. Click on **Property Tax Search** or go to the County Treasurer page and click on **Property Tax Search**
3. Click on **Property Tax & Assessment Information**
4. You will then enter the **Burnett County Public Access** site for tax & assessment information, Click on **Real Estate link** next to the globe.
5. Next enter **ONLY ONE** of the following criteria: *less is more... if entering a road name-do not enter Rd, St etc... just the name of the road.*
 - a. Last Name or Last Name & First few letters of first name (*if last name is common*)
 - b. Site address #
 - c. Tax ID# (located on tax bill), Legacy PIN# or PIN#
