Supervisor salary is currently \$3750.00 per year. Motion to increase their salary by \$500.00 by Wanda, seconded by Judy Larson. 9-0 motion carried.

The clerk's salary is \$14,000 per year. A motion to remain at \$14,000 was made by Judy Larson, seconded by Charlie Strable. 9-0 motion carried.

The treasurer's salary is \$7500.00 per year. A motion to remain at \$7500.00 was made by Charlie Strabel, seconded by Judy Larson. 9-0 motion carried.

Election Workers receive \$15.00 per hour. Motion to remain at \$15.00 by Wanda Washkuhn, seconded by Joe Peterson. 9-0 motion carried.

The Chief Election Inspector receives \$17.00 per hour. Motion to remain at \$17.00 per hour by Wanda Washkuhn, seconded by Dale Larson. 9-0 motion carried.

The standard labor rate is currently \$17.00. Motion to leave the labor rate at \$17.00 by Wanda Washkuhn, seconded by Charlie Strabel. 9-0 motion carried.

Mileage Rate: we have always followed the federal guidelines. Motion to follow the federal mileage rate by Charlie Strabel, seconded by Judy Larson. 9-0 motion carried.

Motion by Judy Larson to set the 2025 annual meeting for the 3<sup>rd</sup> Tuesday of April 15, 2025. 9-0 motion carried.
